

Online Registration for Membership of CSOI
to open
from June 22,2019 (SATURDAY)

CSOI announces online registration of new membership from the eligible 'Group A' officers of Government of India. The online application will be accepted on CSOI website www.csoi.org.in from **June 22,2019 to July 12, 2019** with a processing fee of Rs 1100/- (non-refundable) for each applicant. The application will be accepted till 5 PM on July 12, 2019.

ELIGIBILITY :

As per the bye Laws of CSOI the eligibility for grant of membership is as follows:

- (i) All **servicing and retired** officers of the grade of Deputy Secretary and above to the Government of India from All India Services i.e. IAS, IPS & Indian Forest Service.
- (ii) Group 'A' officers of **equivalent status servicing** under the Central Government.

{Membership will be open only to Group 'A' officers working under the Central Government}

"The eligibility status of Group 'A' officers who are eligible for membership of CSOI for grant of membership **will include members of All India Services constituted under Article 312 and Central Government Group 'A' officers whose recruitment rules are framed under Articles 309 of the Constitution.** All India services are governed by rules made under the provisions of All India Service Act, 1951 and Central Civil Services are governed under rules formulated under Article 309 respectively".

Guidelines for Applying ONLINE

- 1) Visit CSOI Website www.csoi.org.in
- 2) Click on **APPLICATION FOR REGISTRATION** (On Right hand side on website)
- 3) Fill all the required details. Attach the required documents along with photo.
- 4) Application will be accepted online with a Registration and processing fee of ₹ 1100/- (non-refundable & inclusive of GST @ 18%) on CSOI website <https://:csoi.org.in> through the SBI payment gateway only.
- 5) Click SUMBIT Button.

Following documents are to be attached with the application:-

- a) Photograph
- b) Official ID copy.
- c) Salary Certificate (Copy of latest pay slip)
- d) Proof of Employment (In Service certificate)

A screening committee under DoPT will examine all applications for eligibility & accord approval by 30th October 2019.

A list of approved membership will be posted on website & members will be required to deposit their fee within 30 days from the date of approval.

NOTE:

1. APPLICANTS ARE REQUESTED TO CHECK THEIR ELIGIBILITY BEFORE SUBMITTING ONLINE APPLICATION ALONG WITH THE REGISTRATION FEE.
2. PLEASE RETAIN THE UNIQUE REGISTRATION NUMBER (URN) GENERATED ON SUBMISSION OF YOUR APPLICATION FOR FUTURE REFERENCES.
3. THE STATUS OF VALID APPLICATIONS WILL BE AVAILABLE ON THE CSOI WEBSITE AFTER THREE MONTHS (TIME TAKEN FOR SCRUTINY OF APPLICATIONS).
4. NO TELEPHONIC QUERIES OR EMAIL CORRESPONDENCE SHALL BE ENTERTAINED BY CSOI ON THE STATUS OF APPLICATIONS.
